### GOLF LIVADA - LOCAL RULES

#### A-1 Defining Boundaries

Out of bounds is defined by the line between the course-side points at ground level of white stakes.

#### A-4 Internal Out of Bounds

During play of hole 16, the area on the left side beyond the line defined by green/white stakes is out of bounds. These stakes are treated as boundary objects during the play of hole 16. For all other holes, they are immovable obstructions.

#### B-2 Relief on Opposite Side of Red Penalty Area

When a ball has last crossed the edge of the red penalty area on hole 4, marked with red/black stakes, as an extra relief option adding one penalty stroke, the player may drop a ball on the opposite edge of the penalty area under Rule 17.1d.

#### E-10 Protection of Young Trees

Young trees identified by stakes are no play zones.

#### F-1 Defining Abnormal Course Conditions and Integral Objects

Fixed watering equipment, tee signs within the course, wooden pillars in the bunker of hole 10, gravel around the lakes on holes 7 and 10, the transformer stations on holes 2, 11 and 12 are immovable obstructions – free relief available under Rule 16.1a. Ground under repair includes drainage channels covered with soil – free relief available under Rule 16.1a. Stone wall (bridge) on hole 6, stone wall on hole 18, big rocks on holes 7 and 10 are integral objects – NO relief.

#### F-17 All Roads and Paths Treated as Obstructions

All roads and paths on the course, even if not artificially-surfaced, are treated as immovable obstructions, from which free relief is allowed under Rule 16.1.

All measurements are in meters. Marks 50-200 m are to begin off the green (1 stripe = 50 m).

Time limit 9h = 2h 10 min; 18 h = 4h 18 min

#### ETIQUETTE

Practice swings on the tees are not allowed. Players, searching for a ball (max. 3 min.), should signal the players behind them to pass through. 2-ball matches (flights) are entitled to pass a 3- or 4-ball match, a single player has to give way to a match of any kind. An 18-hole match has precedence over any 9-hole match. Repair divots, pitch-marks, shoe damages. Rake and smooth the bunkers. Do not drive carts and cars between a green and a bunker.
